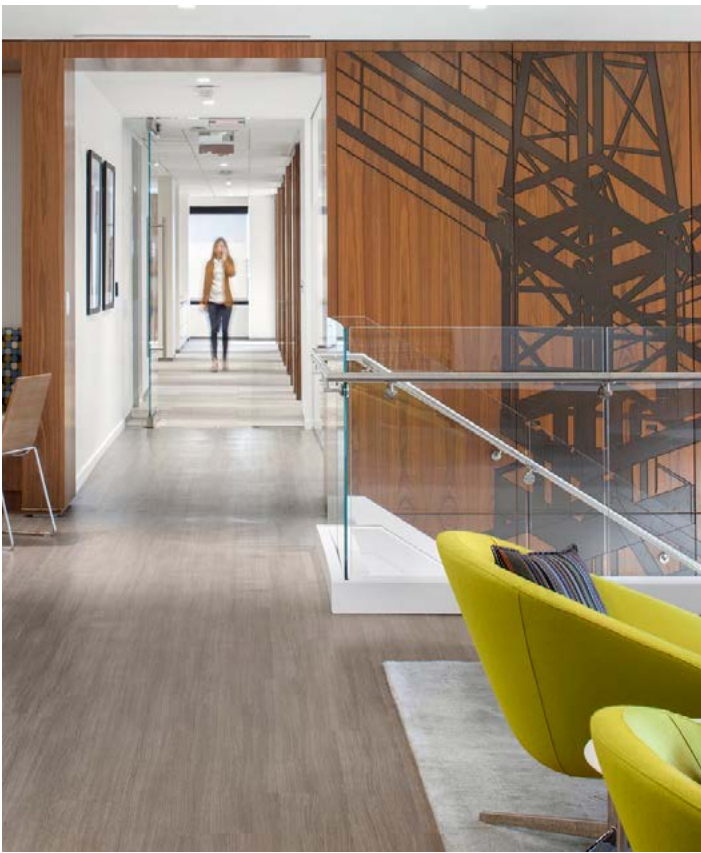

Watt Tieder, a global construction law practice, engaged IA for the relocation of their corporate office in McLean, VA. After a visioning session and focus groups with partners of the firm, project goals were established, including the need for spatial infrastructure for social and professional staff interactions, a functional and efficient footprint that redefines spatial hierarchy, bright and healthy spaces, and a timeless design. Weighing these goals, the IA design team provided test-fits for four different buildings that allowed the firm make the best selection.

The selected, new construction building offers an abundance of natural light, panoramic views, and room for future expansion. From the main reception, the 10th floor features a large, divisible conference room with a catering pantry, support spaces, and offices for the corporate accounting and IT departments. Leading to the 11th floor, the open staircase features a routed wood panel wall with a construction crane graphic perfectly aligned to the stair angle. At the top of the stairs, a cafe/attorney lounge becomes the heart of the space for gatherings, social interactions, collaboration, or "alone together" work.

As the practice floor, attorneys and support staff are all within effective proximity of each on the 11th floor. All partner offices are universally sized and glass-fronted with sit-stand desks and adjacent to shared, "corner office" team rooms. Two open administrative assistant stations, for every eight partner offices,

create light-filled team zones with collaborative tables, file and book storage, and a library setting with seating. Flexible case rooms are available to tackle a diverse range of assignments and double as team rooms with the appropriate mix of technology and furnishings.

While access to natural light and views make the space feel welcoming, it also plays a crucial role in occupant wellbeing by reinforcing the natural rhythm of work, intuitive wayfinding, and, consequently, productivity. Light is celebrated and strategically unblocked from windows at the corridor ends, team and community spaces, and office fronts. Careful coordination of mechanical systems and lighting allowed for high ceilings, further spreading the natural light into the building's core.
